背景 Background

日本政府於2023年8月22日宣布,於2023年8月24日把福島核電站的核污水經處理及稀釋後排放到海洋。

The Government of Japan announced on 22 August 2023 to discharge the treated nuclear-contaminated water generated in the process of cooling the reactors at the Fukushima nuclear power station (FNPS) into the ocean on 24 August 2023.





- ▶ 因應日本政府的決定,食環署署長已發出《食物安全命令》(《命令》),並於8月23日刊登憲報,禁止源自日本10(都)縣的水產食品進口本港。
- ▶ In response to the Japanese government's decision, the Director of the Food and Environmental Hygiene Department (FEHD) has issued "Food Safety Order" ("Order") and was gazetted on 23.8.2023, prohibiting the import of aquatic products originating from 10 metropolis/prefectures in Japan into Hong Kong.

Those foods originating from the four prefectures near Fukushima Prefecture, namely Ibaraki, Tochigi, Chiba and Gunma, must be accompanied by a radiation certificate and an exporter certificate issued by the Japanese authority before they can be imported.







Consignment clearance procedure(Imported by sea route)

食安中心向進口商發出的食物檢驗通知書 Food Examination Notice issued to the importer.



在食物批次抵港後,進口商使用表格 FEHB 301向食物進口管制辦事處 (特別職務)提交抵港報告及相關文件。

Upon arrival of the consignment, importer submit arrival report (FEHB 301) together with relevant documents to FICO(SD).



在食物批次抵港後,進口商使用食物貿易商入門網站在網上提交抵港報告。

Upon arrival of the consignment, importer submit arrival report online via the Food Trader Portal (FTP).



在食物批次抵港報告獲接納後,衞生督察/食品管制主任與進口商聯絡,以作輻射檢測安排。

After acceptance of a consignment arrival report, health inspector/ food control officer will contact the importer by phone or email for arrangement on radiation testing.



衞生督察/食品管制主任作實物檢查及抽取食品樣本作輻射檢測,相關批次暫時不會放行,直至檢測結果滿意。

Health Inspector/Food Control Officer conduct physical inspections and take food samples for radiation testing, the relevant consignment would be undergoing temporary hold until satisfactory result obtained.

在食物批次抵港後,進口商使用表格 FEHB 301向機場食物檢驗辦事處提交抵港報告及相關文件。

Upon arrival of the consignment, importer submit arrival report (FEHB 301) together with relevant documents to AP office.

在食物批次抵港後,進口商使用食物貿易商入門網站 在網上提交抵港報告。

Upon arrival of the consignment, importer submit arrival report online via the Food Trader Portal (FTP).



在食物批次抵港報告及相關文件獲接納後,衞生督察/食品管制主任與進口商聯絡,以作輻射檢測安排。

After acceptance of a consignment arrival report and relevant document, health inspector/ food control officer will arrange radiation testing.



衛生督察/食品管制主任作實物檢查及抽取食品樣本作輻射檢測並在機場實驗室進行檢測 ,相關批次暫時不會放行,直至檢測結果滿意。

食物批次清關程序

Consignment clearance procedure

- ▶ 食安中心人員在日本食品進口時檢查相關文件(例如空運和海運提單、載貨清單等文件)和貨品標示,以及相關受管制食品的輻射證明書和出口商證明書(適用於八月二十四日前已實施的管制措施及非水產品)等。
- 如有需要,食安中心人員亦會向相關進口商了解情況。一般而言,食品原產地資料會載列在貨品的標示或載貨清單中
- ▶ 如水產品並非在受管制的都/縣收穫、製造、加工或包裝,純粹是經受管制的都/縣轉運或運輸到香港,則相關水產食品不在《命令》禁制範圍之內。
- Staff of the CFS will check the relevant documents (such as air waybill and bill of lading, packing list, etc) and the label of goods as well as the radiation certificate and exporter certificate of the food products (applicable to import control measures that have been implemented before August 24 and non-aquatic products) when foods are imported from Japan.

If needed, staff of the CFS will also contact the relevant importers to learn more about the situation. In general, information on the place of origin will be carried in

the label of goods or the packing list.

Aquatic products that are not harvested, manufactured, processed, or packed in the regulated metropolis/prefectures but are simply transited or transported through the regulated metropolis/prefectures on their way to Hong Kong are not under the scope of regulation of the Order.





食物批次清關程序 Consignment clearance procedure

- ▶每批貨品的清關過程需時多久,則取決於多項因素,包括相關文件或資料是否清晰齊備、進口批次數量多少,以及當時是否有多批貨品同一時間抵達而延長輪候間等。現時機場三個貨運站均配備冷藏設施供進口商使用,在等待食安人員安排進行檢測期間,可按其需要將食品暫存於這些冷藏設施。
- The duration of clearance process for each consignment depends on multiple factors, such as clarity and completeness of the related documents or information, the number of consignments, and whether many consignments arrive at the same time, leading to long queues, among others. Refrigeration facilities are provided at all three cargo terminals at Hong Kong International Airport for importers to store food and the trade can use the refrigeration facilities for storage of food while waiting for inspection when needed.





網上報告食物批次抵港

Online reporting of food consignment arrival

- ▶ 食安中心鼓勵進口商經「食物貿易商入門網站」(Food Trader Portal 簡稱FTP)網上報告食物批次抵港,以便加快食物批次清關程序。進口商在 FTP開立帳戶後,便可在網上報告食物批次抵港。在收到報告後,網站會按特定的運作流程向進口商發出指示,以完成貨物放行手續。業界如對使用FTP有任何疑問,可致電3108 2753與食安中心職員聯絡。
- The CFS encourages the importers to report online through the Food Trader Portal" (FTP), in order to expedite the procedure of consignment clearance. Importers with FTP accounts may report arrival of food consignments online. After receiving the report, the FTP will issue instructions to the importers for completion of the consignment release. For any enquiries on using the FTP, please contact staff of the CFS at 3108 2753.





食物監察 Food Surveillance

- 樣本分析Analysis of samples
- 如有關食物未能通過手提測量計或輻射污染監察系統的檢測,樣本會交由政府化驗所作進一步輻射檢測。 Food items with testing results that exceed the level on the hand-held survey meter or Contamination Monitoring System, the alleged food samples will also be sent to Government Laboratory for further radiation testing.
- 如檢測結果不合格,中心會將涉事食物批次封存並作 進一步跟進。
 - If unsatisfactory results are obtained, CFS will mark and seal the products concerned and take further follow-up action.





不受新措施影響的水產品 Aquatic products not affected by the new measures

- 以下的水產品不受新措施影響:
- The following aquatic products are not affected by the new measures:
 - 新措施生效前已經進口香港的水產品
 - Aquatic products that have already been imported into Hong Kong prior to the implementation of the new measures

 - Aquatic products that have been shipped prior to the implementation of the new measures

- 以下的水產品不受新措施影響:
- The following aquatic products are not affected by the new measures:
 - 水產品並非在受管制的都縣收穫、加工、製造或包裝,純粹是 經受管制的都縣轉運或運輸到香港及
 - Aquatic products are not subject to harvesting, manufacturing, processing, or packing via 10 regulated metropolis/prefectures and transshipped or transported from 10 regulated metropolis/prefectures and
 - 進口商向食安中心作出聲明水產品來源地不是受管制10個都/ 縣及沒有在受管制10個都/縣製造、加工或包裝
 - The importer declares to CFS that the aquatic products are not originated from 10 regulated metropolis/prefectures and have not been undergone manufacturing, processing, or packing processes in 10 regulated metropolis/prefectures.





所需的補充資料/文件/證明文件 Supplementary information/document/proof required

- ▶ 入口商/出口商/製造商提供證明相關食品於2023年8月24日前被收穫、製造、加工或包裝的文件/記錄。
- Documents/records to demonstrate that the products in question were harvested, manufactured, processed, or packed before 24 August 2023 by the importer/ exporter/ manufacturer.
- ▶ 入口商/出口商/製造商提供證明相關食品並非在日本的十個都市/ 縣內被收穫、製造、加工或包裝的文件/記錄。
- Documents/records to prove that the products in question were not harvested, manufactured, processed, or packed in the ten Metropolis / Prefectures in Japan by the importer/ exporter/ manufacturer.
- ▶ 改善相關食品的標籤。例如包裝附加貼有原產地/生產日期的標籤
- ► Enhance the label of the implicated food items. For example, post addition label with place of origin/production date





進口前需要注意的事項和加快清關小貼士 Point to note before importation and tips on speed up the import clearance

- ▶ 進口前需要預備相關文件(例如空運和海運提單、載貨清單等文件),而相關載貨清單必需準確列出有關貨品名稱、數量、重量、產地來源地等資料。
- Well prepare the related import document (e.g. Airway Bill, Bill of lading, packing list etc.). Packing list should properly list out the product name, quantity, weight and origin information etc.
- 為鼓勵進口商利用網上報貨系統,食物安全中心會為已預先使用食物貿易商入門網站提交抵港報告的進口商作優先處理清關安排。
- To encourage importer using the online report arrival system. Centre of Food Safety will handle such consignment with priority on submission of arrival report via the Food Trader Portal (FTP)
- 入口商須提醒出口商預先檢查所有出口食品的來源地是否與 載貨清單相符,包括食品的包裝標示。
 The importer should remind the exporter to pre-check origin of all
- The importer should remind the exporter to pre-check origin of all the exported food and match the packing list submitted including the packing label.
