注意事項 Notes for Attention

- (1) 簽發《動物製食品衛生證書》是食物環境衛生署（食環署）為本港出口商提供的服務，確保其含有動物成分的食品符合進口國家／地區的獸醫衛生規定。證書條款以進口國家／地區的規定為準。
This is a public service provided by the Food and Environmental Hygiene Department (FEHD) to assist local exporters of foods of animal origin in meeting the veterinary health requirements imposed by importing countries/places. Conditions of the “Health Certificate for Foods of Animal Origin” are subjected to the requirements of the importing country/place.
- (2) 申請人（出口商）提交《動物製食品衛生證書》申請之後，不一定會保證獲簽發衛生證書。食環署必須檢視有關食品製造過程，確保完全符合進口國家／地區相關的要求，才會簽發衛生證書。
Submission of an application for the “Health Certificate for Foods of Animal Origin” does not guarantee the issuance of such certificate. FEHD must inspect the food manufacturing process concerned to ensure all requirements specified by importing countries/places are fulfilled before issuing a health certificate.
- (3) 除非另有說明，已簽發的《動物製食品衛生證書》有效期一般由進口國家／地區決定。
The validity period of issued “Health Certificate for Foods of Animal Origin” is generally determined by the importing country/place unless specified.
- (4) 每張《動物製食品衛生證書》僅涵蓋一個食品種類。
Each health certificate will cover one type of food commodity only.
- (5) **首次申請 First-time application**
食環署獸醫公共衛生組會對首次申請《動物製食品衛生證書》的相關食品加工廠進行初步審核，以確認該食品加工廠是否符合申請衛生證書的資格。申請人（出口商）須於食環署確定初步審核結果滿意後，才遞交衛生證書的申請。有關詳情，請聯絡食環署獸醫公共衛生組查詢。
Veterinary Public Health Section of FEHD will conduct a preliminary assessment to the Food Processing Plant which is applying the “Health Certificate for Foods of Animal Origin” for the first time to confirm its eligibility for application of health certificate. Application for health certificate should be submitted after confirmation of satisfactory assessment result by the Veterinary Public Health Section. Please contact the Veterinary Public Health Section of FEHD for details.
- (6) 證書費用：以一張航運／空運／陸路提貨單或進出境載貨清單所列的一批食品計算，申請一張衛生證書的現行費用為港幣 8,455 元正。相關申請只於繳付費用後處理。已繳付的申請費用將**不會退回**。
Certification fee: currently HK\$8,455 per certificate application for each consignment of food products under one bill of lading/air waybill or one Import and Export Manifest. Applications will only be processed after payment. The paid application fee is **not refundable**.
- (7) 申請人（出口商）須確保在食環署檢視期間能夠提供一切所需的正確資料；並確保在遞交申請表時，盡可能把該等資料載列或夾附於申請表內。
It is the responsibility of the applicant (exporter) to ensure that all the necessary and correct information is available to FEHD at the time of inspection, and is presented in the application form or attached thereto at the time of application as far as possible.
- (8) 為確保食環署能在食品生產期內安排和檢視食品製造過程，申請人（出口商）必須在申請表內的生產詳情一欄中列明生產日期／時段，否則有關申請將不獲受理。
In order for FEHD to arrange and inspect the food manufacturing process within the food production period, the date(s)/period of production must be stated under the item of “Production Details” in the application form. Otherwise, the application will not be accepted.
- (9) 申請人（出口商）必須在遞交申請表格及在申請獲核對後，才開始相關出口食品的生產。
The production of the export food products must only commence after having submitted the application form by the applicant (exporter) and given that the application has been verified.

- (10) 由於食環署在處理和安排檢視食品製造過程需時，因此申請人（出口商）應盡早提交申請。
As time is required for FEHD to arrange and conduct an inspection of the food manufacturing process, applicants (exporters) are thus advised to submit applications well in advance.
- (11) 食環署檢視後有可能要求申請人（出口商）提交更多資料及／或文件。若申請人（出口商）未能在檢視後三十天內提交這些資料及／或文件，食環署可能會拒絕簽發《動物製食品衛生證書》，並沒收已繳付的指定費用。此外，食環署若認為食品不符合相關的規定，也不會簽發衛生證書，而申請人（出口商）已繳付的指定費用亦不會發還。
After the inspection, FEHD may request the applicant (exporter) to submit further details and/or documents. The “Health Certificate for Foods of Animal Origin” may not be issued and the paid prescribed fee may be forfeited if the applicant (exporter) is unable to provide the full details and/or the documents as may be required by FEHD within 30 days after inspection. In addition, if FEHD is not satisfied that the export food products have met the specified requirements, the health certificate will not be issued and the paid prescribed fee will be forfeited.
- (12) 食環署在檢視後，倘證實食品符合相關的規定，而申請人（出口商）亦已呈交所有相關文件，署方一般會在兩個工作天內簽發《動物製食品衛生證書》。
After the inspection, if FEHD is satisfied that the export food products have met the specified requirements, the “Health Certificate for Foods of Animal Origin” will normally be issued within 2 working days upon receipt of the full set of documentation from the applicant (exporter).
- (13) 申請人（出口商）須注意，假如食品已離開香港，或已鎖入貨櫃內準備送往目的地，食環署或不能更改《動物製食品衛生證書》的內容。因此，申請人（出口商）必須核對衛生證書的內容，確保資料正確無誤。
Applicants (exporters) should note that it may not be possible for FEHD to amend the “Health Certificate for Foods of Animal Origin” for food products which have already left Hong Kong or which are locked in containers ready for delivery. Therefore, the applicant (exporter) should check that all necessary details have been correctly included in the health certificate.
- (14) 申請人如使用便利通關准許作申請，可能須就個別食物項目提交由認可機構發出的食品檢測證明書及報告，證明食品符合中華人民共和國國家標準。申請人須為有關抽樣檢測要求作出適當安排。
Applicant who uses the Advance Release Permission for application may be required to provide a certificate with relevant test report issued by a recognised institute certifying that the food product complies with the national standard of the People's Republic of China. The applicant shall make appropriate arrangement for the sampling and testing requirements.
- (15) 上述內容如有任何改動，恕不另行通知。請與食環署獸醫公共衛生組聯絡。
Any changes in the abovementioned notes will not be notified individually, please contact the Veterinary Public Health Section of FEHD for details.
- (16) 簽證服務如有任何爭議，食環署保留最終決定權。
FEHD reserves the final discretionary right on any disputes regarding the certification service.

Certain postage fee will be charged if the applicant chooses to receive the “Health Certificate for Foods of Animal Origin” by Registered Post. The concerned postage fee shall be subject to the payment notice for the application for “Health Certificate for Foods of Animal Origin”. The paid postage fee is **not refundable**.

收集個人資料聲明 Personal Information Collection Statement

(1) 收集資料的目的 Purpose of Collection

你在本申請表格所提供的個人資料，會由本署作申請《動物製食品衛生證書》用途。提供個人資料與否純屬自願。但如果提供的資料不足，我們可能無法處理你的申請。

Your personal data provided by means of this application form will be used by this Department for the purpose of application of “Health Certificate for Foods of Animal Origin”. The provision of personal data is voluntary. However, if you do not provide sufficient information, we may not be able to process your application.

(2) 資料轉交的對象 Classes of Transferees

你所提供的個人資料，主要供本署內部使用，但亦可能在有需要時就以上第 1 段所列的用途向其他政府部門或有關人士披露，包括食物出口目的地國家/地方主管當局。此外，你的個人資料只會披露給你曾同意向其披露的相關各方，或用作《個人資料（私隱）條例》所核准的資料披露。

The personal data you provided are mainly for use within this Department but if required, they may also be disclosed to other government branches and departments or relevant parties, including the authorities of the destination country/place of food export, for the purposes mentioned in paragraph 1 above. Apart from this, the data may only be disclosed to parties where you have given consent to such disclosure or where such disclosure is allowed under the Personal Data (Privacy) Ordinance.
